As per constitutional provisions of JSGIF, the Election of the Managing Committee, General Council Members of the Group are required to be conducted in November / December 2018. Form 'A' (along with correctly calculated contribution) & Form 'B' are mandatory to be sent, which should reach to JSG Int. Federation office, Mumbai on or before 25th January 2019. Form 'A' & Form 'B' are attached here with in Three Copies.

Contribution @ 5% of Membership fees of your group, minimum Rs. 50/- and maximum Rs. 150/- per couple member along with Rs. 25/- publication Levy plus GST on entire amount @ 18% is due to be paid by each Group along with Form 'A' and at least one mailing list of all members be Sent by 25th January 2019 along with previous years dues (if any) to JSG Int. Federation Office Mumbai.

Since the accounting year of the Group is from April to March, Fees to be Collected from members and payment of contribution to Federation shall initially be sent by the group on the basis of earlier year membership strength. Any additional payment or claim of refund of excess contribution (if any) shall be sent / claimed at the time of sending final Form 'A' on or before 30th June 2019.

- 1) Appointment of Election Officer by a Group : Preferably on or before 10th December 2018
- 2) Date of Notice for Election of Group : Preferably on or before 12th December 2018
- 3) Group Managing Committee Election : on or before 31st Dec. 2018

- 4) Elections of Group Office Bearers, Managing Committee (including nomination of three Former Presidents of Group) : With in 10 days of Election of the Group (Latest By 10th January 2019)
- 5) Submission of Form 'A' & Form 'B' : Should reach to JSGIF Office Mumbai on or before 25th January 2019 (along with contribution & one copy of Membership List)
- 6) Provisional Payment of Contribution (with Form 'A') : It should reach to JSGIF Office Mumbai on or before 25th January 2018
- 7) Regional Office Bearers & International Directors Election (Voting by New Team 2019-21) (on the basis of - New Form 'B') : Preferably on or before 15th March 2019
- 8) Federation Office Bearers Election & other appointments. : on or before 31st March 2019
- 9) Remaining balance Contribution by the Group (with Revised Form 'A' in case of short payment /Claim of refund for excess payment) : On or before 30th June 2019 (along with Revised list of Membership)

It may be noted that eligibility of numbers of International Directors from each Region shall be on the basis of membership strength as on 30th September 2018 as per provisions of the Constitution of JSGIF.

NORMS & RULES FOR REGION & FEDERATION ELECTIONS : 2019-21

01. The Election of International Directors for JSGIF and Region Office Bearers shall be conducted in respective Region as per provision of Constitution of JSGIF.
02. Number of International Directors to be elected in Region shall be on the basis of membership recorded in the JSGIF from their Region Groups as on 30th Sep. 2018.
03. The Eligibility of all Contesting Candidates shall be as per clause no.12[A] and 14[B] of the Constitution of JSGIF as well as the Standard Constitution, their Group should be also qualified as per Clause 15 read with Clause 8 of the Constitution of JSGIF.
04. General Council Members of Group who fails to furnish Form 'B' Seven Days (7 Days) before the date of Election and fails to pay the Contribution as per Clause 8 due for the year 2019-21 by the time of Election shall not be entitled to take part in the Election Meetings and Voting.
05. All the GROUPS presently in existence and formed thereafter Chartered by the Federation shall be member of the federation until they are De-Chartered and the candidates from such Group are Eligible to contest the Election of Region / Federation. No candidate will be Eligible if their Group has not taken the Charter before 30th November 2018.
06. If needed, the Election shall be conducted by Ballot Papers on which Names of the Candidates shall be printed in English alphabet order of Name.
07. Additional Vote for the Groups having Couple Members more than 300 and 500 shall be decided on the basis of payment of Contribution of the preceding year as per clause 17c.
08. To observe Election, each Eligible Candidate is entitled to depute one Chief Agent and shall furnish details with two passport size color photos before seven days of the Election.
09. On Election Day, Promotion, Publicity, Canvassing or Propaganda of any nature by Candidates are strictly prohibited in the land mark compound of Election and Meeting Area.
10. The expenditure for Election will be in a reasonable limit and the Election Commission shall monitor the same.
11. More than one eligible General Council Member from the same Group cannot contest the Election of the International Director for JSGIF.
12. More than one eligible General Council Member from the same Group cannot contest the Election of the Office Bearers of Region.
13. Election Commission shall fix the system and procedures of Election of the Federation as well as the Region accordingly wherever necessary.
14. The time frame of Regions / Federation Election will not be extended unless unavoidable circumstances / or if decided in Election Commission.
15. 'A' & 'B' Form of the Group submitted in stipulated time will be considered as the final documents of the Group for eligibility for nomination and voting.
16. Copy of the Audited Accounts Receipt & Payment Account with no of member.

17. Vacancy of the Regional Office Bearers : In the event of any casual vacancy occurred during the term, it shall be filled by amongst eligible Candidate of such Region by the Board of International Directors of Federation.
However, vacancies remaining vacant on account of no nomination/s or ineligible Candidate shall be filled by the Board of International Directors after proper review and from Eligible Members from the same Region only.
18. Vacancy of the Board of Directors of Federation : In the event of any casual vacancy, in the Office Bearers and Board of Directors, it shall be filled by Board of International Directors amongst eligible Candidates.
However, vacancies remaining vacant on account of no nomination/s or ineligible Candidate, shall be kept vacant but if found necessary, may be filled by International Directors after proper review and from Eligible Members **only** from respective region and such candidate can not be a Office Bearer.
19. All the candidates filing nomination form for International Director will pay Rs. 10,000/- with the nomination form. This amount will be non-refundable in any case the candidate wins, loses or withdraws in election. This amount to be paid by cheque / D.D. in favor of "Jain Social Groups Int. Federation".
20. All the candidates filing nomination form for Region Office Bearer will pay Rs. 5,000/- with the nomination form. This amount will be non-refundable in any case the candidate wins, loses or withdraws in election. This amount to be paid by cheque / D.D. in favor of "Jain Social Groups Int. Federation".
21. The Norms, Rules & Procedures laid down by Election Commission will be final one. During the course of Election, if any Candidate find any doubt or difficulty must get in touch with Election Commission and must not enter in any argument or conversation with Region Election Officers / Volunteers on duty. In all the cases decision of Election Commission will be final one and will be binding to all.
22. No Candidate or it's Group initiate any legal action or challenge Election Process or Election once the Election Procedures are started. If any Candidate has any grievance shall first refer to the Federation through the Resolution by Managing Committee of his / her Group only, the Federation shall either decide or appoint Arbitrators as per constitution and their decision shall be final and binding to all the concern. Candidate / Group needs to give an undertaking for not to initiate any direct legal Court Case.
23. Any member & Board of Directors of JSGIF or office bearers of JSGIF or Region office bearer, not attending mor than 50% meetings every year in his year of Election shall not be eligible for next term of Election.
24. All the Elections for Group, Region & Federation will be governed & subject to the provisions of the currently in effect EGM approved constitution of JSGIF.
25. Legal jurisdiction shall be Mumbai Court only for all the matters.
26. Relevant provision of JSGIF Constitution such as Clauses 8, 9, 12, 14, 15, 17, 25, 29 etc. are enclosed herewith for ready reference.

JSGIF CONSTITUTION : ELECTION RELATED CLAUSES

Clause-8. ADMINISTRATIVE CONTRIBUTION

- (i) Groups who shall pay an annual contribution and taxes thereon to the Federation which shall be 5 percentage of the total membership fees received by the Groups from their members subject to 5% of Minimum Rs. 1000/- and Maximum Rs. 3000/- of membership fees per couple member for carrying out various activities of the Federation Plus Rs. 25/- yearly per couple member for publishing a bulletin, magazine or other literature of the Federation.
- (ii) **Method of Payment of Contribution :**
 - (a) Each Group shall pay every year on or before the 25th January, Annual Contribution provisionally calculated on the basis of its membership fees as reported in Form 'A' and finally difference by 30th June on the basis of Membership and their fees.
 - (b) A Group formed during the year shall pay contribution on the proportionate basis.

Clause-9. GENERAL COUNCIL

[A] Representation of the Groups:

All the Groups shall be represented on the Federation through their members on the General Council as provided in the manner specified in sub clause (B) hereunder:

[B] Constitution of the General Council:

The General Council of the Federation shall be constituted of the following Members.

- (i) All the Office Bearers of the term of all the Groups not exceeding five as per Standard Constitution from each Group.
- (ii) Immediate Former President of each Group.
- (iii) Three Former Presidents from each Group nominated by Managing Committee of the respective Group. Nomination once made cannot be varied till the end of the term of the nominated member unless such nominated member resigns or dies or ceases to be a member of the Group.
- (iv) The nomination under Sub-clause above should be intimated to the Federation by the President of the Group or in his absence, by the Joint Signatures of Secretary and Joint Secretary of the Group within such time as may be prescribed by the Central Council. Nomination once made cannot be varied till the end of the term of the nominated member unless such nominated member resigns or dies or ceases to be a member of the Group.
- (v) All the Former Presidents of the Federation provided he continues to be member of any Group.
- (vi) Former President of the Group who are co-opted by the Central Council for respective term.

Clause-12. ELECTION OF BOARD OF DIRECTORS OF FEDERATION ETC

[A] Eligibility:

- (i) For all the post of International Director of JSGIF from various Region minimum requirement is Former President of a Group who is General Council member and has served any office for one term in Federation or two terms as Office Bearer in Region. And He should be a member of Mutual Benefit Scheme of JSG Welfare Scheme and shall continue as member provided he/she is eligible for M.B.S. criteria.
- (ii) If there is more than two post of International Director in the Region one post of International Director shall be reserved for Former President of a Group who is General Council Member and who has served at least one term as Director of Board or Federation Office Bearers or as Region Chairman.
- (iii) For the post of President Elect minimum requirement is that he should have served any two term as Office Bearer of Federation. For Secretary General minimum requirement is that he should have served at least one term as Office Bearer of Federation or as Chairperson of Region.

(B) ELECTION :

- (i) All the Election of the JSGIF shall be held every year, till 2017-18 & 2018-19 General Council member of next year shall elect candidates for various post Out of themselves for next year term as per specified Eligibility & thereafter the TERM of TWO YEARS shall be effective from year 2019-20
(NOTE : Election of the President Elect for the term 2019-21 shall be held along with the Election of 2019-21.)
- (ii) Region Election shall be held in time on or before Marc 15th except in the exceptional cases.
- (iii) Election of International Directors, of JSGIF shall be held along with Regional Elections.
- (iv) In the event of any casual vacancy, in the office bearers and Board of Directors it shall be filled by Board of International Directors amongst eligible person.
 - a) Officer Bearers of JSGIF can not hold the same post for more than 2 (two) terms.
(NOTE: Election of the President Elect. for the year 2019-21 shall be held along with the Election in 2019-21.) Office Bearers of JSGIF & REGION can not hold the same post for more than 2 (Two) terms.
- (v) President Elect of immediate preceding year shall become International President for next term automatically.

(D) ELECTION COMMISSION :

Election Commission consist of one Election Commissioner and two Members shall be appointed by the Board of International Directors of Federation by 31st May every alternate year and election commission shall nominate Election Officer and members in each Region preferably in consultation with Federation President & The Region Chairpersons for smooth and timely election of the Region and Federation. If any Region does not hold Election within prescribed time frame & hold the election without taking consent of the Election Commission, then in that case Election Commission reserves the rights to withhold or cancel such election.

- (1) Name of The Election Officer of the Region may be recommended by the Out going Chairman of the concerned Region
- (2) Place of election To be recommended by the Incoming Chairman. And preferably at a place as per the convenience of the Region.
- (3) Date of Election : within the prescribed time limit as specified by the Election Commission. (say between 1st. Feb. to 15th. March)

Clause-14. CONSTITUTION OF REGIONAL COMMITTEE:

(A) A Regional Committee shall consist of the following persons:

- i) All the elected regional office bearers out of General Council Members of the groups of that Region and Two PRO (Former President / G. C. Member) appointed by regional office bearers.
- (ii) All the International Directors and Former Presidents of the Federation from such Region.
- (iii) All Former Chairman of such Region.
- (iv) All Zone coordinators who are former president of a Group.
- (v) Regional conveners as appointed by Region office bearers out of former Presidents of groups.

(B) Regional Office Bearers Eligibility & Election Procedure :

- (i) (a) For Chairman Elect minimum Qualification is Former President of a Group who is General council member and have served Two terms of office bearer in Region. (Applicable from 2018-19 election)
- (b) For Vice Chairman and other post of Region Office Bearers minimum qualification is Former President who is General Council Member. However relaxation may be granted to elect the members of Regional Committee from General Council Members by Election Commissioner or Election Officer of such Region in consultation with Election Commissioner and Federation President.
- (ii) Regional Chairman Elect of immediate preceding year shall become Region Chairman for next term automatically
- (iii) General Council Members of a Region shall Elect, Two Vice Chairman, One Secretary, Two Joint Secretary & One Treasurer from the General Council members of the Group.
- (iv) Region Committee shall also appoint Zone Coordinators and various Committee and its Convenier out of Former Presidents of Groups.
- (v) Restriction for the Election of the Chairman: Once a person is Chairman of the Region from a Group, no other person from such Group shall be elected as the Chairman Elect of the Region for the term until such person ceases to be Region Chair person.

(D) Election of the Regional Office Bearers:

- (i) Election of the Regional committee will be held every two year
- (ii) In the event of any casual vacancy, it shall be filled by the Regional Committee amongst eligible members of such Region or in its absence by the Board of International Directors of Federation.
- (iii) In case of any vacancy of I.D. in a Region, It can be filled up by the Board of I. D. from the same Region only and those I.D. can not become / can not be made Office Bearers of JSGIF. If a Region strength is reduced to less than Eight(8) Groups. In that case said Region should be merged with nearest Region or may be closed.

Clause -15. FAILURE TO PAY CONTRIBUTION, TO HOLD ANNUAL GENERAL MEETING ETC BY THE GROUP

If any Group fails ;

- (i) To hold Annual General Meeting of the Group in a calendar year.
- (ii) To present the Audited Annual Accounts in AGM. (Audit Optional for Groups upto 75-100 Couple members.) But submission of Accounts to the Federation is compulsory.
- (iii) To elect the members of Managing Committee in the Extra Ordinary General Meeting and to elect Office Bearers of the Group at the meeting of the newly elected Managing Committee within 10 days of E.G.M and names of such office Bearers elected is intimated to the Federation every 2nd. year in the prescribed ' Form 'B' in writing so as to reach Federation Office on or before 25th. January .

(iv) To pay the Annual Contribution as per the provisions of the constitution along with form 'A' Before 25th every year & balance by 30th June. Form B & A both should be filed before 25th January.

If any Group fails to pay the balance contribution by 30th. JUNE then in that case, any member who is elected anywhere (Group / Region or Federation) will cease to be Elected person on respective post.

(v) If the membership of the Group is reduced to less than the one hundred members or 50 couples.

(vi) To follow the standard constitution of the Jain Social Group. Then any Eligible candidate represented by such Group shall not be entitled to stand for election of the Federation or Region. In case of non payment of annual contribution by Group its General Council Members shall not be entitle to take part & Vote in the meetings of Region and Federation until annual contribution is paid. Such members can Vote, if their Group's Contribution is paid at least 5 (five) days before Election date.

Clause -17. GENERAL MEETING

(C) Voting Power:

At the time of Election all the member of General Council referred in clause 12 of the Federation will be entitled to have one vote.

Provided that all the member of the General Council of the Federation representing a Group whose Couple Membership strength is more than 300 in the preceding year, will be entitled to have one additional vote and a Group whose Couple Membership strength is more than 500 in proceeding year will be entitled to two additional votes. (President Elect in JSGIF & All Chairpersons Elect in Regions shall have Voting Rights in the Election, irrespective of whether they are Gen. Council Members or not.

Clause-25. ARBITRATION

No group or its members shall initiate any legal case against Group, Region or Federation in any court of law directly or otherwise.

In case of any dispute aggrieved members shall apply for an arbitration to their groups with a copy to Federation and if deemed fit Group shall apply for the same within 30 days or Max. WITHIN TWO MONTHS from the DATE OF DISPUTE ARISES, against Region or Federation to Board Of International Directors through Federation office bearers. On receipt of application of arbitration with prescribed fees of Rs.5000/-, arbitrators shall be appointed by Office bearers of Federation WITHIN ONE MONTH (Mandatory) whose decision shall be final binding upon all the parties. In case of any direct legal action by groups or its members (they) may be removed as member of the group and or group may be De-chartered for a period as may be decided by central council.

Clause-29. JURISDICTION

Legal Jurisdiction of JSGIF (Federation, Regions & Groups) shall be Mumbai Court only under any circumstances for all the matters.

MAMORANDUM OF ASSOCIATION OF JSG INT. FEDERATION:

GROUPS TO BE MEMBERS: All the GROUPS presently in existence and formed thereafter Chartered by the Federation shall be member of the Federation until they are De-Chartered and the candidates from such group are Eligible to contest the Election of Region / Federation. No candidate will be Eligible if there Group has not taken the Charter before 30th November 2018.
